Statewide Stormwater Rule

July 2025, Florida is ushering in a new era of stormwater management with the passage of Senate Bill 7040, unanimously approved and signed into law. This legislation ratifies the long-awaited Statewide Stormwater Rule, marking a significant shift in how stormwater systems are designed, permitted, and maintained across the state.

Spill Prevention

Industrial Stormwater BMPs are measures to prevent or treat polluted runoff from industrial sites, protecting waterways from contaminants like trash, chemicals, and oil.

Implementing procedures to prevent spills and leaks, such as using secondary containment for tanks and drums, and training employees on proper transfer procedures.
